Safe PCR Test and Antigen Speed Test

At the Corona Speed Test Center Ramstein, you can have a COVID-19 PCR or antigen test performed in accordance with RKI guidelines by appointment. We exclusively offer the BfArM-approved ANTIGEN TEST for persons who want to prove, or who have to prove according to the new model quarantine regulation, whether there is an acute infection and thus the risk of infecting other people in the immediate vicinity. The detection is carried out via a throat swab. We also offer **PCR testing**, which is **required for international travel**. The result of the PCR test is sent by e-mail the following evening – mostly by 11:30 p.m. (except for tests on Saturdays or public holidays).

The booking page is in English and guides you through the booking menu.

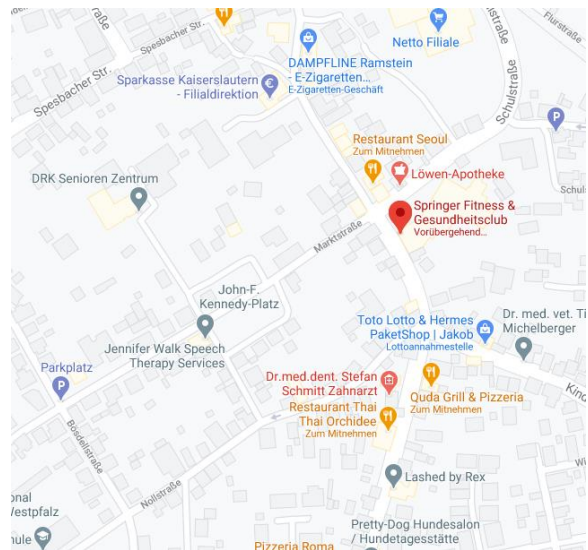
You will receive an appointment confirmation by mail. If you choose an Antigen Test for Travel or an PCR Test you can pay for the test on-site when you come to the appointment.

We perform a COVID 19 antigen tests or PCR tests.

What does a test cost?

A antigen test costs 45 € . For adolescents and children the test costs 40 €. You can buy and pay for the test on site.

A PCR test costs 40 € plus laboratory costs of 61.36 € (78.69 € for persons residing abroad)

Can I come without an appointment?

Due to the current situation, we can only allow appointments by prearrangement, as long queues in front of the facility should be counteracted. You can book your appointment here [>>click here<<](#)

How can I pay on site?

You can pay cash or by EC/credit card on site.

Can I use the test to shorten my travel quarantine?

Federal as well as state government regulations regarding quarantine after a return trip from a risk area change regularly and adapt to the current situation. As of 08/01/2021, the antigen test can be used to reduce your travel quarantine.

Can I cancel my rapid test appointment?

If you are unable to keep your booked appointment, please notify us immediately by emailing info@coronatest-ramstein.de.

Why should I do two tests on two consecutive days?

The antigen test increases its significance if you perform two tests on two consecutive days.

How do I get the test?

Make an appointment online. This shortens your waiting times.

Who performs the test?

The test is performed by medical professionals.

How long does the test take?

The test itself takes a maximum of 5 minutes. The test result for a antigen test is available about 15 minutes later.

The test result for a pcr test will be emailed to you the day after sample collection between 4 p.m. and midnight (except for tests on a Saturday - in which case you will receive the test result the following Tuesday evening). If you have any questions about the test result, see also "[How can I contact the lab](#)".

Can I get a faster evaluation of a PCR Test on the weekend?

For an additional charge of 200 €, a special trip can be made on Sunday. You will then receive the result of your test already on Monday, by 11:45 p.m. at the latest.

How is the smear test performed?

The swab is taken painlessly with a cotton swab in the mouth and throat.

Does it hurt?

No, the test does not hurt.

Will I receive a certificate about the test result?

Yes, for both tests you will receive a certificate about the presence of a positive or negative antigen test.

In which language will the certificate be issued?

The certificate of an antigen test for travel is issued in German and English.
The certificate of an PCR test is issued in English.

How can I contact the lab if I have questions about my PCR Test result?

If you have questions about the test result, you can contact the lab at corona@arminlabs.com. Please refrain from contacting the lab ahead of time as the sending of results can NOT be expedited. The result is usually transmitted by 11:30 p.m. at the latest. The mentioned e-mail address will be checked by the laboratory at regular intervals until 1 a.m.

General terms and conditions

As a customer you receive the performance of a SARS-Cov.19 antigen speed test or a PCR Test after taking a swab from the nose or throat area.

1. We provide this service for you with reference to the following general terms and conditions:

- The swab collection is carried out with the greatest possible care and may possibly be associated with basically normal, tolerable pain or inconvenience. You release us from any liability except for intentional / grossly negligent actions;
- the reliability of the rapid test is very high, without us being liable to you, the customer, with regard to the test result
- a negative test result is equivalent to proof that there was no Covid-19 load at the time the test was performed, and that normally no such viral load has been released for at least 18 hours since the swab was taken;
- However, we will digitally archive the test result for a period of 14 days for follow-up purposes.
- Due to the availability of BfArM listed rapid test kits, we work with different approved rapid tests. The COVID-19 rapid tests used may therefore be from different manufacturers. Illustrations used on the website show exemplary test kits - all test kits used are BfArM listed, but may differ from the illustrations or specifications.

2. Warranty and liability

We will use our best efforts to perform the test to the best of our ability in accordance with current pandemic requirements. The warranty on our part is limited to the subject of the test order, the application of appropriate hygiene measures and compliance with the usual requirements for the performance of rapid tests. The customer must immediately notify us in writing of any obvious defects or complaints about the service. We shall remedy these defects within a reasonable period of grace or provide the service again. Any further claims for damages due to non-performance or possible inconvenience are excluded. Claims for defects are excluded insofar as party 2 has not properly cooperated.

3. Liability for damages

We are not liable for lost profits, lost savings or other damages of the customer, unless they were caused by us or our agents by intent or gross negligence.

4. Confidentiality / Data Protection

Confidential information within the meaning of these provisions is all information that we receive and that is either designated as confidential or whose confidential nature, such as that of the customer's personal data, is evident. Confidential information is carefully protected and used only in the context of the contractual relationship. We ensure that confidential information is made available only to those employees and other service providers who have been obligated to maintain confidentiality in order to fulfill the contract. This data will be deleted after 30 days at the latest in accordance with the applicable data protection regulations.

5. Revocation

The customer is entitled to revoke the declaration directed at the conclusion of the contract with us within two weeks in writing (letter, fax, e-mail) without giving reasons. The period begins with the order in our online store. To meet the deadline, it is sufficient to send the revocation in time.

The consent to perform genetic analyses as well as the notification of results can be revoked in writing at any time.

6. Place of performance and jurisdiction

Place of fulfillment for all obligations as well as payments is Ramstein-Miesenbach. The place of jurisdiction for all disputes arising directly or indirectly from the contractual relationship is Landau/Pfalz for both parties. The law of the Federal Republic of Germany shall apply.

7. Final provisions

A judicial/official recognition of the test result is not guaranteed; if the customer intends a corresponding use, the clarification of the suitability is their responsibility.

Subsidiary agreements, amendments and additions to these General Terms and Conditions must be made in writing.

The invalidity of individual provisions of the General Terms and Conditions as well as the individual contracts shall not affect their validity in other respects. An invalid provision shall be replaced by a provision that best reflects the intention of the contracting parties as expressed in the invalid provision.
